# GREENVILLE ARENA DISTRICT BOARD MEETING November 28, 2023 – 4:00 pm Minutes

Chairperson Patel called to order, for the purpose of doing business, the Greenville Arena District Board of Trustees, held on November 28, 2023, at 4:00 PM.

#### Minutes:

Mr. Russo made a motion to approve the October 24, 2023, Greenville Arena District Meeting Minutes. The motion was seconded by Mr. Dyer. There was no opposition to the minutes.

### Management:

Mrs. Paul began by welcoming the group and sharing the Management Report, Month Ending October 2023 (handout provided). Mrs. Paul shared that the Bon Secours Wellness Arena hosted 7 events with revenue coming in favorable to budget by \$30,000. However, October attendance was 40,000 with the annual attendance for Q1 currently at around 132,250. Unfavorable operating expenses due to insurance premiums actual vs. projected, personnel one-time payout, change in accounting for merchant fees, overlapping POS license with installation of new POS system.

Mrs. Paul presented the strong Booking Pipeline with an anticipated \$7.26 million in projected event revenue.

Diving into management updates, Ms. Paul stated that the Greenville Arena District implemented a zero- waste recycling effort for Dave Matthews that continued through Alabama. Many challenges with the logistics, cost, and manpower involved. Overall was successful and laid a foundation for future implementation. Mr. Smith shared initiatives implemented by other arenas.

Ms. Paul shared that the Swamp Rabbits season is off to a stronger start than the prior season. Attendance increased by 17% compared to last season with per capita spending increasing by 10%.

Ms. Paul provided a deeper look into Community Relations specific to Non-Profit Organizations. Ticket donations, Concession Sales Sharing, In-Kind Space Donation, Staff Volunteering, Monetary Donations, Signature Events, Stage Partners, and Community Leadership & Professional Associations are the many ways we are giving back to the community. Ms. Paul also discussed and provided a handout with specific information relating to media relations, and related value and impressions.

Ms. Drummond discussed adding BSWA to the list for Project Feed 5000.

#### Finance:

Mr. Formanack will have the new proposed investment policy emailed to the board for review, with a plan to vote in the December Board Meeting.

## Public Outreach:

Ms. Drummond stated that Ms. Paul had provided the updates in her previous presentation.

## Capital Improvements:

Mr. Dyer – did not share an update.

Mr. Pittman shared information on the City Club of Greenville f/k/a Commerce Club and recommended a meeting between BSWA management and City Club management.

The next meeting of the Greenville Arena District Board will be held virtually on Tuesday, December 19<sup>th</sup>, at 4:00pm.

## **Executive Session Motion:**

Mr. Patel asked for a motion to enter Executive Session for the purposes of discussing Real Property. Mr. Russo made the motion, and the motion was seconded by Ms. Drummond.
